This is regarding Compliance Report submitted by Nagarjuna College of Engineering and Technology, Venkatagiri Kote Post, Devanahalli, Bangalore-562164, Karnataka for the UG Civil Engineering program which was accredited by NBA in Tier-II for academic years 2018-19 to 2020-21 and whose validity of accreditation is expiring on 30.06.2021.

2. The National Board of Accreditation (NBA) has decided that in all cases of UG Engineering programs which were accredited in Tier I/Tier II for the Academic Years 2018-19 to 2020-21 i.e. up to 30-06-2021 and for which the concerned Institutions have submitted Compliance Reports, but, the visit of Expert Team for data verification of the programs is pending because of the current pandemic situation due to Corona virus, the programs will be considered for accreditation of one year i.e. up to 30-06-2022 after data verification of the programs internally on the basis of the submitted Compliance Reports. The data submitted by Nagarjuna College of Engineering and Technology, Venkatagiri Kote Post, Devanahalli, Bangalore-562164, Karnataka in the Compliance Reports has been examined and verified in NBA. Based on the same, the Competent Authority in NBA has approved the following accreditation status to the programs as given in the Table below:

The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to Nagarjuna College of Engineering and Technology, Venkatagiri Kote Post, Devanahalli, Bangalore-562164, Karnataka as a whole. 
